I assume all risk of injury, liability, and loss arising from my participation or presence at said activity. This Waiver, Release and Hold Harmless is in consideration of the Village of North Palm Beach permitting my participation in the activity. I

freely and voluntarily assume all risk of loss or injury arising from my participation in the activity whether due to my negligence or the negligence or intentional acts of others. By signing this waiver, I agree to indemnify the Village of North Palm Beach and any and all employees of the Village of North Palm Beach from any and all damages which result from any and all acts or omissions, including negligence, in whole or in part, on the part of any Village employee.
